Clarification No. 3 to the Bidding Documents is issued in accordance with Sub-Clause 7.1 of the Instructions to Bidders (ITB)

QUESTION NO. 1:

BILL 1000; Items 14.01 (a, b, c and d): The numbers provided in the 'Description' column is different from the number provided in the 'Quantity' column: For example, for Item 14.01(a), the number in the description column is 2, but the number in the Quantity column is 1. Similar case applies to Items 14.01 (b, c and d). Please clarify.

Response to Question No. 1

The Items 14.01 (a, b, c and d) are to be quoted as Lump sum. Thus, for Item 14.01 (a), the amount to be inserted in the 'Amount' column, is the total cost, i.e. Lump sum amount of 'providing 2 no. Type I houses fully furnished and equipped' shown in the 'Description' column. Similarly, for Item 14.01 (b) the amount to be inserted in the 'Amount' column, is the total cost, i.e. Lump sum amount of 'providing 3 no. Type II houses fully furnished and equipped' shown in the 'Description' column. Similar case applies to Items 14.01 (c and d). For these lump sum items, the 'Qty column' and the 'Rate column' are supposed to remain blank.

Following the explanation, we are sorry to admit that the amount of '1' in the 'Qty column' was inserted by mistake. In order to correct the mistake some amendments are proposed to the Bidding Documents – Refer **Addendum No. 2**

Regarding Item 14.01 (e), this is not a Lump sum Item. For this Item, a Rate must be entered in the 'Rate column', and the Amount to be entered in the 'Amount column' is obtained by multiplying the Qty in the 'Qty column' and the Rate.

In addition, the 'Unit' for Item 14.01 (e) is amended to read 'month' instead of '(house unit) x (month)' – Refer **Addendum No. 2**.

QUESTION NO. 2:

BILL 1000; Items 14.05 (a) and 14.06 (a): There is no any quantity shown: Should we write quantity of 3 and 8?

Response to Question No. 2

The Items 14.05 (a) and 14.06 (a) are to be quoted as Lump sum. Thus, for Item 14.05 (a), the amount to be inserted in the 'Amount' column, is the total cost, i.e. Lump sum amount of providing 3 No. Station Wagon Vehicles shown in the 'Description' column. Similarly, for Item 14.06 (a) the amount to be inserted in the 'Amount' column, is the total cost, i.e. Lump sum amount of the 8 No. Double Cabin pick-up vehicles shown in the 'Description' column. For these lump sum items, the 'Qty column' and the 'Rate column' are supposed to remain blank.

QUESTION NO. 3:

BILL 3000; Item 33.01 (a): Quantity is written 0. So, do we have to insert rate only or?

Response to Question No. 3

BOQ Item 33.01(a) is to be deleted entirely and (d) remains. Refer Addendum No. 2
