1.2 Online Participants

It was observed that nine (9) Prospective Bidders' representatives and one (1) Engineer from TANROADS HQ office joined the online pre-bid meeting session while three (4) TANROADS HQ staff attended the Pre-bid meeting.

3.0 PROCEEDING OF THE MEETING

3.1 Opening of the Meeting and self-introduction

The Chairperson informed the Prospective Bidders who were already on the Tanga Airport link that the pre-bid meeting will be held jointly for both Tanga and Lake Manyara Airports. For that matter, the Chairperson requested the Prospective Bidders to switch from the link for Tanga Airport to the link for Lake Manyara Airport. After joining the two meetings in one link, the Chairperson welcomed all the participants. He informed the Prospective Bidders that there was a mix up of timing for pre-bid meeting for Lake Manyara whereas the Specific Procurement Notice indicated 14:00 hours the Bidding Documents indicated 10:00 hours. Further, the Chairperson informed the participants for the purpose of time saving and given the fact that the works on both tenders are similar, the Client thought it was wiser to join the two meetings as most of the Prospective Bidders are the same for the two tenders. Therefore, the pre-bid meeting for Lake Manyara airport is held jointly with Tanga airport now and not 14:00 hours. The Chairperson opened the meeting at 10:15 hours Local Time (East African time) by welcoming all participants. All participants were given an opportunity of introducing themselves.

3.2 Opening Remarks

The Chairperson explained that the project for Rehabilitation and Upgrading of Lake Manyara Airport, Tender No. AE/001/2022-23/HQ/W/09 and Rehabilitation and Upgrading of Tanga Airport, Tender No. AE/001/2022-23/HQ/W/07(TZ-TANROADS-383619-CW-RFB) is funded by the World Bank (WB) under the Tanzania Transport Integrated Project (TanTIP) and that the project is on tight implementation timelines. Thus, the prospective bidders are advised to observe the deadline for submission (i.e. 26th January 2024).

Further, the Chairperson, briefed the prospective Bidders as follows:

- (i) The Pre-bid meeting is held pursuant to ITB 7.4 of the Bidding Documents;
- (ii) The meeting is aimed to provide clarifications on the Bidding Documents and the site visit Video posted in TANROADS' website;
- (iii) The Bids opening (Technical Part) is scheduled to be held on 26th January, 2024;

- (iv) No answer will be binding unless it has been issued in writing, as part of the Pre-Bid Meeting Minutes;
- (v) Deadline for TANROADS to receive requests for clarifications from prospective bidders is 21 days before the Bids submission date (i.e. on 5th January 2024);
- (vi) TANROADS will ensure that all responses are provided before or on 12th January, 2024 (i.e.14 days before the Bids submission date) through Prospective Bidders' email addresses and TANROADS website provided in the Bid Documents;
- (vii) All the verbal responses to the queries shall be confirmed in writing;
- (viii) Minutes of Pre-bid meeting will be prepared and sent through email. The same will be uploaded to www.tanroads.go.tz;
- (ix) Participants are expected to have an opportunity to view the Site Video:
