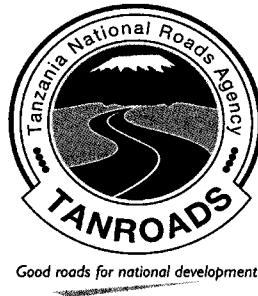

Clarification No. 2 to the bidding document is issued in accordance with Instructions to Bidders, Sub-Clause 8.1 of the Bidding documents:

QUESTION NO. 1

Some specifications include names of specific brands. This may disadvantage bidders that wish to offer alternative brands. Are we allowed as authorized distributors of other brands to offer equivalent models to those requested?

Bidders are allowed to offer alternative brands with similar parameters which comply with the Technical Specifications.

QUESTION NO. 2

It will be difficult to provide manufacturer authorizations for low value items. It is unlikely that original equipment manufacturers will provide authorization for items whose value is not significant. Please advise.

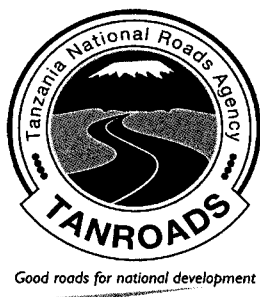
