Clarification No. 2 to the Bidding Documents is issued in accordance with Instructions to Bidders, Clause 8.1

Question:

As per Addendum No. 2 to the Tender Documents issued on 7th November 2017, the original BOQ has been amended to incorporate the requirements below, among others:

We request you to clarify the following:

- (i) Are there any technical specifications / requirements for the different equipment listed?
- (ii) Is the price closed to TShs. 2,000,000,000.00. If so, please specify the list of "other accessories as approved by TCCA" so it is possible for us to calculate how to strictly remain within the provided budget.
- (iii) For which unit does "PS" stand for?

Response:

- (i) Technical specifications / requirements for the different equipment listed for the Item 7.2 will be issued to the successful Bidder during contract implementation.
- (ii) The list of "other accessories as approved by TCCA" will be issued to the successful Bidder during contract implementation. Bidders are not expected to make any calculations. Calculations, if any, will be carried out by the successful Bidder during contract implementation, for consideration by the Employer after specifications / requirements relating to the item have been firmed up. Hence, for the Item 7.2, Bidders are not expected to enter any amount in the BOQ "Quantity" and "Rate" columns.
- (iii) "PS" stands for "Provisional Sum". It is an amount inserted by the Employer towards the cost of an Item, whose scope / specifications / requirements cannot be established with certainty, and it is utilized during contract execution strictly as instructed by the Employer. In this particular case the Provisional Sum that has been allowed in the BOQ for the Item 7.2 is TShs 2,000,000,000.00, to be utilized during contract implementation by the successful Bidder, strictly at the discretion of the Employer.
