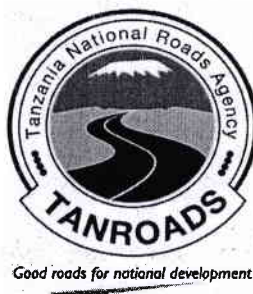

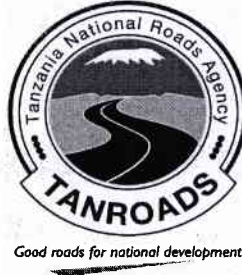

**QUESTION NO. 1:**

Reference to Part 1 - Bidding Procedures/Section III Evaluation and Qualification Criteria/2.3. Financial situation /2.3.1 - Historical Financial Performance: It is understood that, financial situation of years 2013-2017 shall be demonstrated by the tenderer. Please confirm.

***Response to Question No. 1***

Response to Question No. 4 of Clarification No. 1 is hereby withdrawn and replaced with the following:

*The assessment of Financial Situation for the last five years will cover the Years 2014 to 2018.*

**QUESTION NO. 2:**

Section II, Bid Data Sheet: ITB No. 20.1 requires the Bid to be submitted in one original and three copies. We would like to get the clarification of the following:

- (a) If the "technical envelope" containing the company documents and qualifications covering the required qualifications can be **only one set** comprising 1 original and 3 copies to cater for all lots in which participated instead of submitting of one independent set ( original and three copies) for each lot.
- (b) And the Financial envelope be in one envelope for each Lot in which participated.

**Response to Question No. 2**

*The suggestions (a) and (b) are not acceptable. We wish to emphasize that for each Lot tendered, Bids must be submitted in 1 Original and 3 copies, plus electronic copy of priced BOQ in MS Excel, as stipulated under ITB 20.1. For submission, sealing and marking of Bids refer ITB 21.1.*
