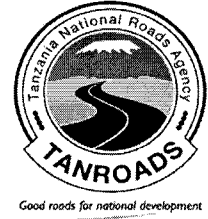

Clarification No. 1 to the Bidding Documents is issued in accordance with Sub-Clause 8.1 of the Instructions to Tenderers (ITT)

QUESTION:

Volume 1, Section 1 – Invitation for Tenders. Paragraph 4 provides as follows:

“Bidders should note that to qualify for award of the contract, they are required to meet certain minimum qualifying criteria as provided under Volume 1 – Section IX, Tender Forms – 6. Qualification Information of the Tendering Document which includes:

- (i) Experience as Prime Contractor, they should have successfully completed at least **two (2) projects** of similar nature and complexity within the last ten (10) years, each with a minimum value of **TZS 80 Billion** or its equivalent in a freely convertible currency.
- (ii) Average Annual Construction Turnover of at least **TZS 150 Billion** or its equivalent in a freely convertible currency, in the past 5 years (2015 – 2019).
- (iii) Minimum amount of liquid assets and/or credit facilities net of other contractual commitments of **TZS 20 Billion** or its equivalent in a freely convertible currency.
- (iv) Further details and complete qualification requirements are provided in the Tendering Documents.

Tenderers should also note that the works must be completed within **Twenty-Four (24) months inclusive of three (3) months of mobilization.**”

Please clarify whether the requirement “**Tenderers should also note that the works must be completed within Twenty-Four (24) months inclusive of three (3) months of mobilization.**” applies to the Upgrading of Malagarasi - Ilunde – Uvinza Road (51.1 Km) project or the projects cited under item (i) above.
