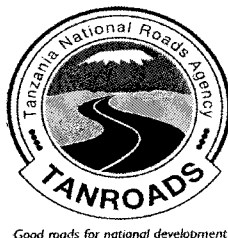

MINUTES OF THE PUBLIC TENDER OPENING SESSION FOR ROAD SAFETY STRENGTHENING ALONG BRT PHASE 1 CORRIDOR, PACKAGE A: WIDENING OF UBUNGO - KIMARA ROAD SECTION AND ANCILLARY WORKS ALONG MOROGORO AND KAWAWA ROADS, TENDER NO. AE/001/2021-22/HQ/W/39

1. INTRODUCTION

The Public Tender Opening Session for Road Safety Strengthening along BRT Phase 1 Corridor, Package A: Widening of Ubungo - Kimara Road Section and Ancillary Works along Morogoro and Kawawa Roads, Tender No. AE/001/2021-22/HQ/W/39 took place on 14th June, 2022 in the TANROADS PMU Room, 2nd Floor, 10 Shaaban Robert Street/Garden Avenue Junction, Dar es Salaam.

The submitted bids which were received within the deadline of submission were visibly placed in the TANROADS PMU Room, prior to their opening.

4. PROCEEDINGS

4.1 Briefing on the Tender Opening Session

The Chairperson opened the Tender Opening Session at 10:06 hours local time and welcomed the participants to the opening session. He informed that the Opening Session was in respect of the tender for Road Safety Strengthening along BRT Phase 1 Corridor, Package A: Widening of Ubungo - Kimara Road Section and Ancillary Works along Morogoro and Kawawa Roads, Tender No. AE/001/2021-22/HQ/W/39. The Chairperson read out the Agenda to be followed and thereafter, he requested the participants to introduce themselves and complete the Attendance Form.

After the introduction, participants were briefed on the events leading to the opening session as follows:

- a) The advertisement of the tender invited and appeared on the newspapers namely "Daily News" of 13th April, 2022, The East African of 16th – 22nd April, 2022.
- b) Deadline for submission of tenders was 27th May, 2022 at 10.00 local hours but was subsequently extended through Addendum No.1 dated 26th May, 2022 to 14th June, 2022 at 10:00 local hours.
- c) **Fifteen (15)** sets of the Bidding Documents were purchased.
- d) **Four (4)** envelopes/parcels has been received by the submission deadline.
- e) The tender envelopes/parcels were registered sequentially in order of submission/receipt starting from No. 1 for the first envelope. The registration numbers were also marked on the corresponding external envelopes. The last envelope received within the deadline for submission was marked in addition "& Last".
- f) The Bidding instructions stipulated that tenders would be opened immediately after the deadline of submission; i.e. immediately after 10:00 hours local time on 14th June, 2022.

After briefing and the presentation of opening procedure, the Chairperson requested the Bidders' representatives to nominate a representative from among themselves to verify the information to be read out, namely: Bidders' names, bid prices, bid securities and other information. Mr. Selestine Ndenga of M/s China Railway Seventh Group Co. Ltd from China was nominated.

5. Opening of Tenders

Before opening, each envelope was checked in turn in the order of registration to ensure that:

- (i) It was marked with the correct information on the outer envelope, and (ii) it was properly sealed.

All the envelopes/parcels bore the correct address and information on the external cover and were properly sealed.

As each envelope was opened in the order of submission, the enclosed documents (originals and copies) were marked on the external cover with the number previously marked on the external envelope.

The following documents/information was verified:

- (i) Name of Tender,
- (ii) Tender Price;
- (iii) Tender Form is signed
- (iv) Amount in the Form of Tender matches the amount in the Grand Summary Page;
- (v) Alternative Tender Price, if any,
- (vi) Discounts, if any,
- (vii) The presence (or absence) of the Tender Security;
- (viii) The presence of Code of Conduct for Contractor's Personnel (ES); and
- (ix) Power of Attorney of the Signatory of the Tender.

Following the verification of the information/documents, the Secretariat announced to the participants, the Bidder's Name, the Bid Price, and other information. The information was also recorded as it was being read out. Mr. Selestine Ndenga, the Bidders' representative, verified the read out information.
