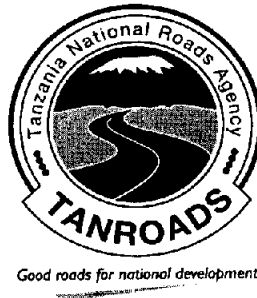

With reference to the questions/queries raised by the prospective bidders and pursuant to Instructions to Applicants ITA 7.1, TANROADS is herewith providing clarifications as follows: -

S/No	Issue/Questions	Clarification/Responses
1.	We are kindly requesting clarification of the above project. According to Section III, Table 1, Qualification Criteria and Requirement of Sub Factor 2.1 History of Non-Performing Contracts, it is specified that non-performance of a contract did not occur as a result of the contractor's default since January 1, 2018, which is different from Section IV Application Forms, Form CON2, which specify that contract non-performance did not occur since January 1, 2013. Please clarify.	Non-performance of a contract did not occur as a result of the contractor's default should be since January 1, 2018 in both Section III, Table 1, Sub Factor 2.1 History of Non-Performing Contracts and Section IV Application Forms, Form CON2.
2.	Request to extend the deadline for submission of Applications by 30 days i.e from 22 <sup>nd</sup> December, 2023 to 21 <sup>st</sup> January, 2024	Please note: The deadline for submission of Applications remain the same i.e <b>22<sup>nd</sup> December, 2023.</b>
